MY BACKGROUND INCLUDES OVER 48 MILLION DOLLARS WORTH OF "ON SITE CONSTRUCTION" OBSERVATION AND INSPECTION WORK AS AN "IOR", (INSPECTOR OF RECORD, DSA, STATE OF CALIFORNIA, SCHOOLHOUSE CONSTRUCTION.) IN ADDITION TO THE WORK I WAS "OSHDP", (OFFICE OF STATEWIDE HEALTH AND PLANNING DEPARTMENT), CERTIFIED TO DO SIMILAR WORK AS AN INSPECTOR FOR HOSPITALS AND INSTITUTIONS, FOR THE STATE OF CALIFORNIA.
