

## 1:00 PM Inclusive Playgrounds: Designing Spaces to Bring Children & Communities Together (HSW)

Play is more than fun and games—it is an essential component in helping children develop critical physical, mental, emotional, and social skills that lay the foundation for adulthood. Inclusive play breaks down barriers and builds community through fostering understanding of our similarities and differences. This course discusses how play impacts child development and describes the options and considerations for designing an inclusive playground that benefits all children and the community.

## 2:00 PM Roofing Wind Speeds (HSW)

In the industry there is a need to sort out the confusion between building codes, uplift rated assemblies, and warranties by explaining what each offer and how they should be considered. To understand the building code, we need to review how uplift is determined and the industry's accepted rating method of roofing assemblies for comparison. After understanding the code criteria, discussion will focus on how roofing warranty wind speed coverage is Regarded by the industry and building code will be reviewed for clarity.

## 1:00-3:00 PM Advanced Accessibility Compliance - The Good, The Bad, The Ugly - Or Why Did I Do That??? 2 HR Advanced Florida Building Code

This Advanced Building Code course addresses the specific requirements of the Florida Accessibility Code for Building Construction and the ADA. The course will instruct attendants in the common errors that have and are occurring in construction relating to accessibility issues. There will be an update as to what the Federal Access Board and the Department of Justice is looking at as it relates to requirements for accessibility. # 3:30 PM Reducing Embodied Carbon (HSW)

Sustainable buildings are crucial to the future of the human race and societies at large. The embodied carbon (EC) content of buildings in their structures and systems can be a tremendous contributor to the Global Warming Potential (GMP) of a building as a final product. There are numerous decision points in the process of visioning and designing a building at which the ED content can be reduced dramatically, enabling us to build with far less impact on global warming than is currently the case. EC will be defined and the sources of EC in buildings from a structural engineering and mechanical, electrical, and plumbing systems perspective presented. The discussion will include recent research on buildings and embodied carbon, focusing on increasing sustainability. Presenters will demonstrate how engineers, architects, and owners can leverage their roles and the available tools to reduce the EC content of their buildings. Includes options for EC reduction and contributions of Architecture 2030 and the SE 2030 challenge.

# 4:30 PM An Overview of Architectural Structural Deck: A Functional Focal-Point for Modern Aesthetics (HSW)

# 1:00 PM Building Enclosure Control Layers Fundaments (HSW)

This course covers the basics of building enclosure control layers: how roofs, walls, and below-grade systems manage heat, air, bulk water, and vapor. Implications of the 2015 International Energy Conservation Code with respect to the building enclosure will be reviewed with specific attention on continuous air barriers, continuous insulation, and window to wall ratio.

# 2:00 PM Concrete Waterproofing and Protection (HSW)

Following a brief review of concrete ingredients, work results and sustainability the course examines causes of concrete deterioration and effective concrete protection via epoxy coatings, waterproof traffic coatings, and water repellants. For each protective treatment, relevant standards, salient characteristics, selection criteria, and drawing and specification consideration are discussed. Participants will come away with knowledge of how to extend the useful lifecycle of new or existing concrete structures.

# **3:30 PM Designing with Metal Ceilings** (HSW)

The most common suspended ceiling in use today is the white acoustical ceiling found in most commercial spaces. As Architects and Designers seek ways to add interest to spaces such as lobbies, libraries and retail spaces, metal ceilings are becoming more common in construction projects on their own, or in conjunction with other ceiling materials. Metal ceilings offer a wide range of colors and finishes; they aid in acoustics, and they are available in many sizes and styles. This presentation will introduce the participant to common metal ceiling systems, while covering design considerations such as panel type, size and finish among other things. The presentation will end with common considerations for specifying a metal ceiling. Presented by Rockfon.
