All sessions will feature small groups that focus on each of the 5.0 Exams in an order that will help facilitate each member's path to licensure.

#### 2+2+2 Program

AIA Orlando and The Orlando Foundation for Architecture provide college scholarships to students that participate in the 2+2+2 program at Valencia College, UCF and UF CityLab Orlando. The scholarship program is available to high-achieving students with financial need who seek to attend and graduate from the nation's first 2+2+2 architectural degree program right here in Orlando.

#### **Continuing Education**

Continuing education is required for all registered architects who practice in the state of Florida and are members of AIA. The Florida Statutes require architects to complete continuing education for licensure, while the AIA requires it for membership. Each is recorded separately, but can be interchanged, within certain quidelines.

The state of Florida requires 24 CEUs, with 22 hours in HSW and 2 hours in Advanced Building Code biannually of every odd year. AIA requires 18 LU Hours, with 12 hours in HSW annually, due the end of the calendar year. To obtain HSW credits, members must take courses through AIA CES registered Providers.



**Credit Provider** If you have a course that is approved for AIA CEUs, we can assist you by hosting your training session. If you need help getting a course approved, visit www. aiaorlando.com/lunch-learns. Once you register and offer a course for AIA CES LU's, it is your responsibility to record and report AIA member credit information within 10 business days of course completion using the Course Attendance Form. Providers must report AIA member credit information each time a course is offered

There are two (2) types of learning units/ credit designations:

1. General Learning Units (LU): All approved provider courses are eligible for general course LU's. General course LU's are reserved for courses on a wide range of topics related to A/E/C profession, in which 75 percent of the course content is not related to HSW topics.

2. Health, Safety and Welfare (HSW or as listed in CES Discovery as LU/ HSW): For a provider to offer LU/HSW designated courses it must meet all of the criteria outlined in the HSW section of the manual and be registered as such. HSW courses tend to be in demand. For more information visit www.aiaorlando.com, scroll over Education and select Credit Provider.
