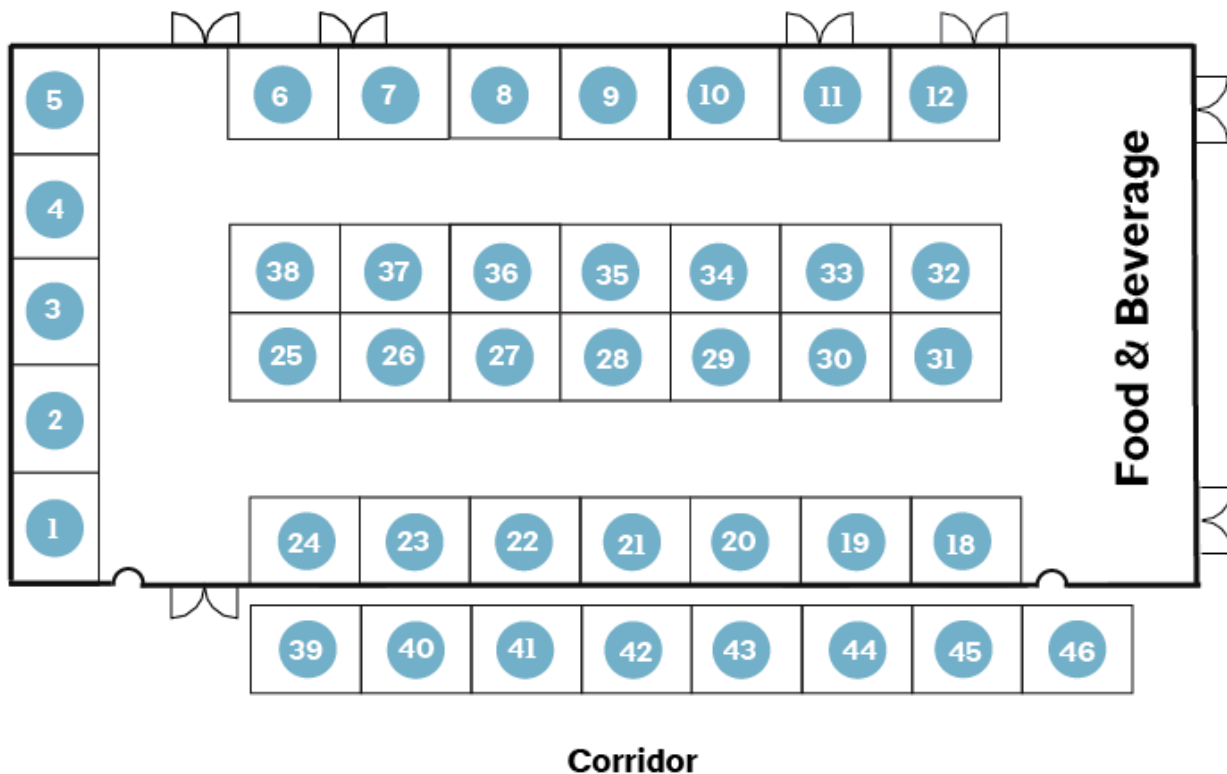

Stucco best practices will be reviewed along with alternate building types such as EIFS, one coat stucco, thin-stone veneer, and direct-applied. Key industry stucco guidelines will be reviewed such as ASTM C1063, ASTM C926, and ASTM C1861.

### **1:00 PM Rainscreen Design with Ultra Compact Surfacing I (HSW)**

Modern construction has come to understand that a façade, as part of an overall building envelope, is not only a visual statement, but also an important influencer in the protection of a wall's structural components, the energy efficiency of the building, and the health of its occupants. This course explores a unique surfacing material known as ultracompact surfacing (UCS) and evaluates its mechanical properties, technical characteristics, and aesthetics to illustrate its endless design potential in exterior cladding, façade, and rainscreen applications.

## 3:30 PM New Fire Resistance Code Compliant Alternative Method Applications I ( HSW)

In wood-frame buildings of three or more stories, cumulative shrinkage can be significant and have an impact on the function and performance of finishes, openings, mechanical/electrical/plumbing (MEP) systems, and structural connections. However, as more designers look to wood-frame construction to improve the cost and sustainability of their mid-rise projects, many have learned that accommodating wood shrinkage is actually very straightforward. This presentation will describe procedures for estimating wood shrinkage and provide detailing options that minimize its effects on building performance. **Presented by WoodWorks-Wood Products Council.**

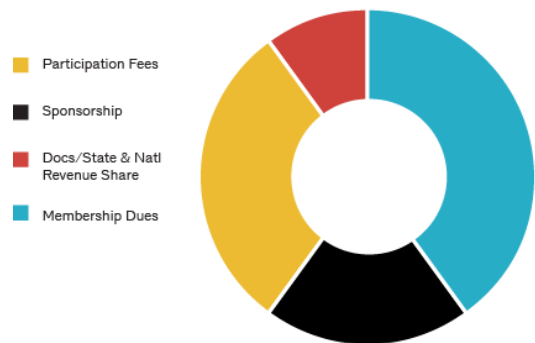

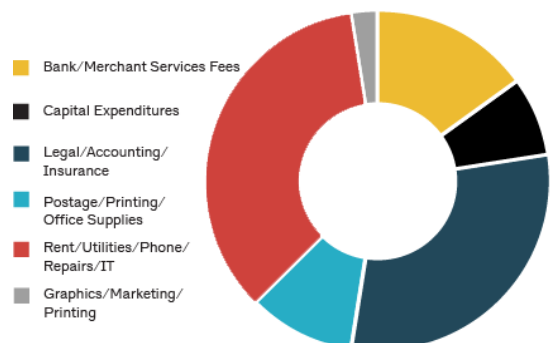

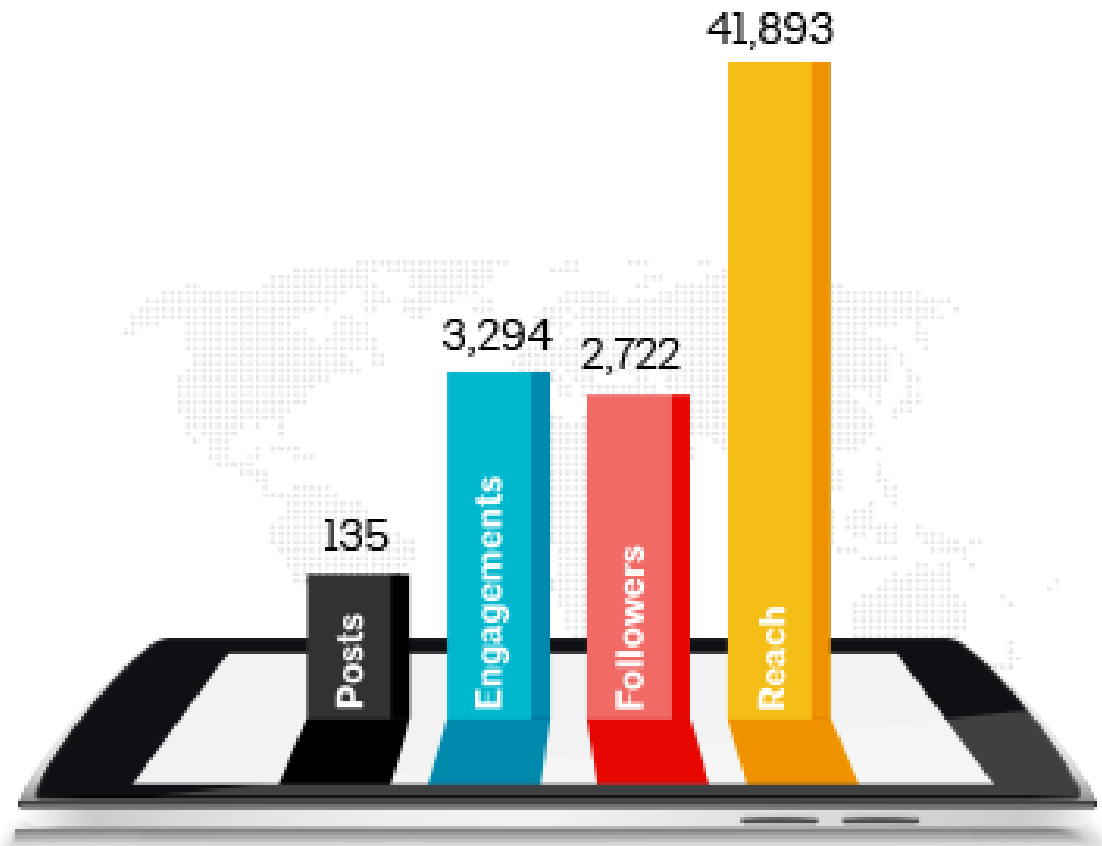

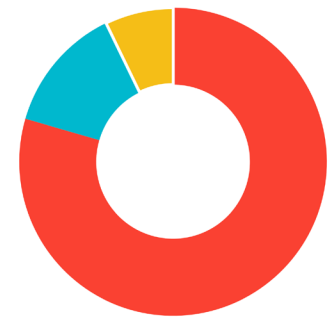

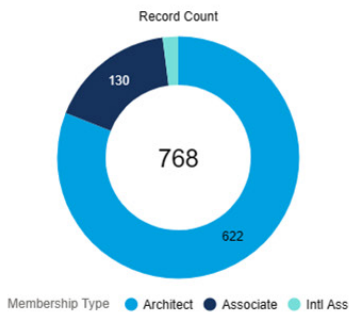

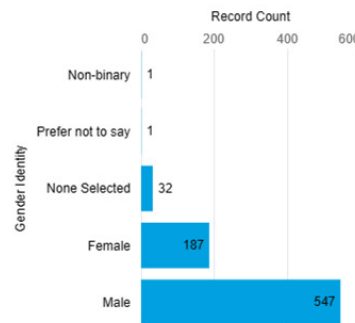

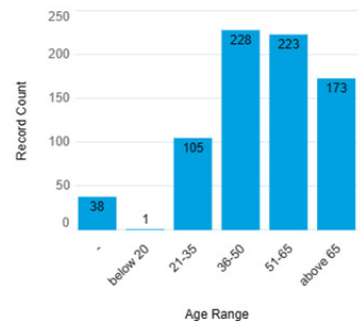
Active Members by Race/Ethnicity

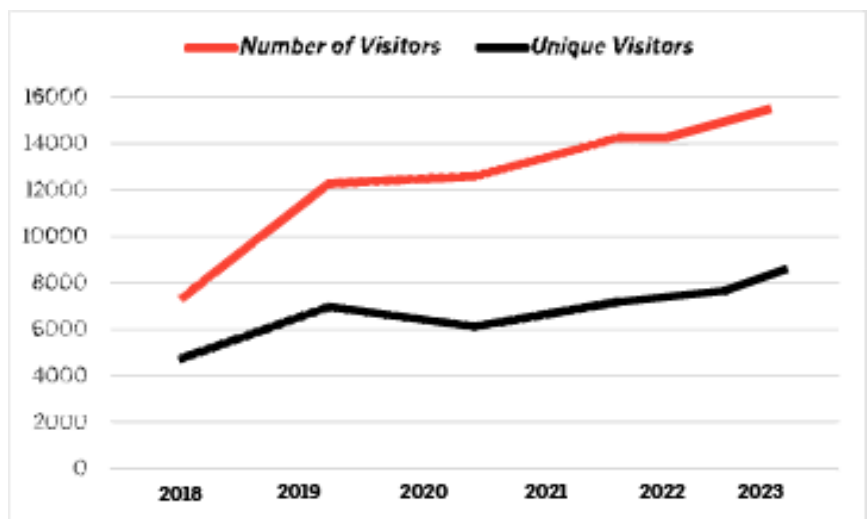
